Relator SEIU’s Notice of Supplemental Authority

Relator Service Employees International Union, District 1199 (“SEIU”) provides this Notice of Supplemental Authority pertaining to its Writ of Mandamus. Specifically, after briefing in this matter concluded, the State Employment Relations Board (“SERB”) issued *State Employment Relations Board v. City of Cleveland*, 2022-ULP-09-0108 (October 26, 2023) (attached hereto). In that case, SERB found that the City of Cleveland committed an unfair labor practice by failing to bargain the effects of implementing its decision to capture audio in the “buffering mode” of police officers’ body worn cameras. Counsel for SERB in this case was also listed as counsel in the *City of Cleveland* case; likewise, the same law firm that is representing Respondent Ohio Department of Rehabilitation and Correction was also listed as counsel in the *City of Cleveland* case.
